### The role of the governing body

The purpose of governance is to provide confident, strategic leadership and to create robust accountability, oversight and assurance for educational and financial performance. The board has resolved to conduct its business by adopting the committee model structure and to delegate statutory functions to a curriculum and learning committee and a finance, resources and premises committee as well as appointing the DfE identified individual delegated governor roles of safeguarding; SEND, and for Kent County Council (KCC) maintained schools: finance and health and safety to report back on their findings.

The governing body appoints DfE identified individual delegated governor roles of Safeguarding; Special Educational Needs and Development (SEND) finance and health and safety to report back on their findings.

## The board has three strategic core functions:

- ensuring clarity of vision, ethos and strategic direction
- holding executive leaders to account for the educational performance of the organisation and its pupils, and the effective and efficient performance management of staff
- overseeing the financial performance of the organisation and making sure its money is well spent

#### Two committee model

Whilst the governing board (known as the board) as a whole remains responsible for the governance function, in this model there are two distinct areas of work delegated by them to a curriculum learning and development committee, and a finance, resources and remises committee.

The curriculum and learning, and finance, resources and personnel committees focus on the delivery of the annual school improvement plan in their respective areas; they may liaise and consult together where necessary, undertake monitoring and evaluation activities against these priorities and report to the board as a whole. In each case where a function has been delegated there is a statutory duty to report any findings, actions or recommended decisions to the board at its next meeting. These reports will in turn inform collective strategic decision making by the board.

At Joy Lane school the governing body work closely in a strategic role with the Executive Headteacher and leadership team in promoting high standards

Individual governors have no power or right to act alone on behalf of the governing body except where the whole governing body has delegated a specific function to that individual or where regulations specify a function is to be exercised in a particular way. The governing body at Joy Lane consists of:

- The Executive Headteacher who is a governor in her own right
- One Local Authority Governor
- Two parent governors who bring a parental perspective to the governing body
- One staff governor
- Five co-opted governors

All governing body members work on a voluntary basis and give their time freely
